The largest and most well established chamber of industry in Turkey with over 20,000 members today, the Istanbul Chamber of Industry was established in 1952 upon the written request of about 750 industrialists.

The Istanbul Chamber of Industry was initially located in the IV Vakif Han, before moving to the Kilavuz Han in Sirkeci, and later to the Kruger Han on Meşrutiyet Street until 2017. On June 12, 2017, Istanbul Chamber of Industry renovated with modern technology and moved to the Odakule building. From then on, all the units of the chamber have started to offer services at this building.

BODIES OF OUR CHAMBER

As with all chambers in Turkey, ICI conducts activities through elected bodies and General Secretary in accordance with the Law No 5171 at the Union of Chambers and Commodity Exchanges of Turkey No. 5174.



• ASSEMBLY PRESIDENTIAL BOARD AND CHAMBER ASSEMBLY

Elected by registered members of the chamber from Sectoral Committee members every four years, the Chamber Assembly is the largest supervisory body within the Chamber. ICI's Assembly Presidential Board is composed of the president, two vice presidents and one secretary, all of whom elected from among the Assembly Members for a term of four years.

Chairman and members of the Board of Directors, Disciplinary Board and Sectoral Commissions are elected by the Chamber Assembly. The assembly convenes once per month to discuss a specific agenda, and may form additional commissions from among its members to investigate and evaluate specific developments when necessary. ICI organization also includes an Accounts Examination Commission and a Legislative Commission. Assembly meetings are held on the fourth Wednesday of every month.





• BOARD OF DIRECTORS

The executive body of the Chamber, the Board of Directors is composed of the Chairman and ten members, elected by the Chamber Assembly for a term of four years. The ICI Board of Directors selects two Vice Chairmen and one Board Treasurer among its members, assigning duties according to the members' area of expertise.



DISCIPLINARY BOARD

The Chamber's Disciplinary Board has six members, chosen by the Chamber Assembly among Chamber members who do not serve on the Assembly, for a term of four years. The Disciplinary Board conducts disciplinary investigations on Chamber members in according to legislative principles and procedures, and recommends the suitable disciplinary action or fines against Chamber members.



• SECTORAL COMMITTEES

Members of our chamber are categorized in various sectoral groups representing the entire manufacturing industry. "Sectoral Committees" consist of representatives selected by the members of each sectoral group. Elections are held every four years. Sectoral Committees convene every month to discuss topics related to their sectors and submit proposals to problems brought forward by the Board of Directors.

Joint Meetings of Sectoral Committees and meetings with ministries are other platforms for Sectoral Committee members to voice their opinions, identify problems of the industry, and discuss potential solutions. ICI considers these events a significant meeting point for the industry, offering the opportunity to integrate public agencies directly into the process of identifying and solving problems.

Industrialists with a headquarter or at least one production facility located in Istanbul and with 10 or more employees are obliged to register with our chamber according to Law No. 5174 on the Union of Chambers and Commodity Exchanges of Turkey and the Law on Chambers and Commodity Exchanges. In an effort to avoid overlapping subscription fees for our members that have memberships in other chambers, we divide the subscription fee at the moment of registration.

CAPACITY REPORT



We provide capacity reports required for many industry-related processes including Industrial Registry Certificate, Food Registry Certificate, Inward Processing Authorization Certificate, Investment Incentive Certificate and Turkish Goods Certificate. The report, valid for two years from the date of issuance, will offer many advantages including low-cost electricity, customs transactions, export incentives and covering of fair expenses.

DOMESTIC GOODS CERTIFICATE

Upon fulfillment of certain conditions, we issue Domestic Goods Certificates for goods listed on the Industrial Registry Certificate which are already produced and have at least 51% domestic input. In public tenders, companies with Domestic Goods Certificate have an advantage at a rate specified in the tender document (up to 15% maximum) over companies without such certificates. Our Chamber also issues Certificate of Manufacturing Competence, Manufacturer's Certificate and Certificate of Good Conduct for Domestic Manufacturing.

We issue Certificates of Origin and of Circulation for your foreign trade activities as well as other certificates required by EU projects.

Within the scope of the Vocational School Cooperation Model that is the strongest one conducted so far, an innovative and effective governance model is implemented with a model aiming to design educational programs in schools that provides vocational and technical education with the sector and prepare graduated students for the business life by increasing their quality.

In schools supported by the ICI,
